**INSTRUCTIONS FOR COMPLETING AUTHORIZED REQUEST FOR MEDIATION FORM**

The Federal Communications Commission (“FCC”) has authorized 800 MHz Transition Administrator, LLC (“TA”) to assist 800 MHz stakeholders in resolving disputes involving the negotiation and implementation of Frequency Reconfiguration Agreements. Disputes involving the implementation of Frequency Reconfiguration Agreements may involve payments that must be made by Sprint directly to a vendor providing reconfiguration services to a licensee. In such cases, the licensee may authorize the vendor to request mediation on its behalf and act in its stead during such mediation by filing an Authorized Request for Mediation.

Before authorizing a third-party vendor to request, or participate in, mediation on your behalf, you should review the TA’s Alternative Dispute Resolution Plan and become familiar with the mediation process. If the TA determines that mediation is appropriate, you will be assigned a TA Mediator who will contact you and the other parties to the dispute and the third party that you have authorized to request, and participate in, mediation.

**About the 800 MHz Transition Administrator**

800 MHz Transition Administrator, LLC (“TA LLC”) is the Transition Administrator (“TA”) for the reconfiguration of the 800 MHz band mandated by the Federal Communications Commission (“FCC”). TA LLC has contracted with Deloitte Consulting LLP, Squire Sanders (US) LLP, and Baseline Wireless Services, LLC to perform the duties of the TA. Among its duties, the TA establishes reconfiguration guidelines, specifies replacement channels, reviews reconfiguration cost estimates, monitors payment of reconfiguration costs, manages the relocation schedule, facilitates issue resolution and administers the alternative dispute resolution process. TA LLC uses information it receives solely for the purposes of administering the 800 MHz reconfiguration process and may disclose such information to the FCC or other authorized parties pursuant to the requirements of the 800 MHz Order or other applicable laws.
