



## Special Temporary Authorizations (STAs)

Due to the Federal Communications Commission's (FCC's) license application freezes related to the 800 MHz band reconfiguration, certain licensees may require Special Temporary Authorizations (STAs) to operate on pre-rebanded channels, and maintain or expand essential facilities prior to completion of the reconfiguration. If a licensee determines that an STA is appropriate, the licensee should submit an STA application to the FCC. No TA prior review or concurrence letter is necessary.

On February 10, 2009, the FCC released a Public Notice (DA 09-213) providing guidance on the permanent licensing of 800 MHz facilities on post-rebanding channels that previously operated on pre-rebanding channels pursuant to an STA. ### Who Pays the Costs Associated with the Frequency Relocation of STAs on the Old Frequency Band?

The FCC in its December 20, 2006 Public Notice (DA 06-2555) indicated that Sprint Nextel will reimburse the cost of relocating facilities that are authorized on a licensee's old frequency band before the end of the freeze of the applicable NPSPAC region. This includes facilities authorized by STAs granted during the freeze.

NOTE: STAs have a six-month term, but are renewable. As such, licensees are advised to be sure to file promptly for renewal if applicable. Additionally, if a licensee has an STA granted after the freeze, the licensee may need to file a waiver. The waiver should request that Sprint Nextel pay for reconfiguration expenses if the licensee seeks to reconfigure such STA at Sprint Nextel's expense.
